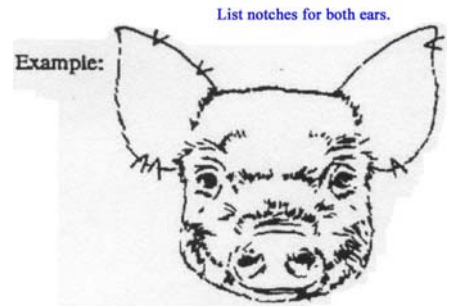

**LIVESTOCK HEALTH PAPERS CHECK POINT:** All Livestock must be inspected and have health papers issued prior to arrival. Health papers will be checked by officials of the Kansas Animal Health Department before entering the Fairgrounds. The inspection booth will be located east of the Fairgrounds at the Fairgrounds Water Park Parking Lot. Enter parking lot from Severance Street between 17th Ave. and 23rd Ave. Access Severance Street from 17th Ave. Daily check-in hours will be 5:00 a.m. to midnight. After your papers are inspected and approved, the officials will give you a signed release that will allow you entry onto the Fairgrounds.
